1. Introduction

This Sustainable Engagement and Education Strategy allows our staff and students to acquire the education, attitudes, and values necessary to create a sustainable environment.

This Strategy sets out our current sustainability initiatives and formalises our strategy into clear objectives and actions. This strategy sits with our other policies and strategies including our Sustainable food policy and Carbon Management Plan and further supports their aims and targets towards strengthening our sustainability agenda.

Our approach involves creating realistic, attainable yet challenging SMART goals that will enable our community to engage with opportunities to promote sustainability on campus and in the wider community.

2. Aims

The overarching aim of this strategy is to create a culture that embeds a sustainable and environmentally conscious mindset into our community. This includes equipping our students with valuable knowledge on sustainability, which in the case of our teacher training students, they will pass on to their students in schools.

Our strategic aims are to:

- empower staff and students to make sustainable choices that improve their environment.
- achieve long lasting change by actively tackling sustainability issues and educating our staff and students.
- educating our students on sustainability so that they can pass on their knowledge to others.

3. Current sustainability Initiatives

We actively demonstrate our commitment to sustainability and social responsibility by creating and supporting sustainability initiatives. These initiatives are led by staff and students who are passionate about creating a culture of sustainability at the university.

Fairtrade

We have been a supporter of Fairtrade since 2011 and were recently awarded Fairtrade one star status for our catering service. We are passionate about maintaining our commitment to Fairtrade and continually work to improve our Fairtrade status by implementing our sustainability strategy.

Our Catering team has expanded its range of Fairtrade soft drinks and confectionery, most notably the addition of Tony's Chocolonely, to encourage the sale of Fairtrade products on campus. They are part of the local Richmond Fairtrade group.

Events and promotions around Fairtrade are often organised by Catering team. In 2022 the service successfully ran various events during Fairtrade Fortnight including presentations from Fairtrade suppliers Tchibo Coffee and Tony's Chocolonely on the importance of Fairtrade. Representatives from the catering procurement team, Students' Union, the University's Sustainability Working Group and the local Richmond Group were also present during the event.

Food Waste Management

We do our best to manage food waste however, sometimes not all the food made in The Refectory is sold. To tackle this issue the catering service has partnered with <u>Too Good To Go</u>, a food service that connects customers to restaurants that have unsold food surplus. Since partnering with Too Good To Go in September 2021, we have saved 550kg of CO2 emissions, the equivalent of driving over 900 miles in a car.

Sustainability Modules

We strive to incorporate sustainability into our modules and courses. Fairtrade is currently embedded in our PGCE teacher training modules mainly within sustainability and education for global citizenship modules. There are also sustainability modules on some of the courses in our Institute of Business Law and Society. We are working towards integrating sustainability modules into all our courses.

St Mary's Student's Union (SMSU)

SMSU actively engages in sustainability campaigns and supports students who are also passionate about sustainability on campus.

They run events such as our annual Sustainability Week campaign and have included events such as the Simmies Swap Shop in which students were able to actively combat fast fashion by swapping and selling their clothes.

Estates & Campus Services

Our Estates team is dedicated to implementing measures that encourage sustainability and reduce our emissions through our Carbon Management Plan.

Measures such as increasing the number of cycle spaces available on campus by 50% and the provision of additional showers have encouraged staff and students to commute by bicycle rather than car or public transport. Staff also have access to a cycle to work scheme.

We have 30 water bottle refill stations across our estate to encourage the use of refillable bottles and reduce plastic waste.

We provide separate recycling bins for general waste and recyclable materials all over campus to ensure that waste is recycled as much as possible.

We have also recently partnered with the Richmond Council with the introduction of food waste bins at several of our residential buildings.

We are addressing the amount of printing we do with a first stage of reducing the number of printers on site, closing our in-house printing service and promoting the use of electronic documents.

Staff and Student Voice

Our Sustainability Working Group is a staff and student group that champion important issues concerning sustainability and work to reduce the university's impact on the environment. This group works with SMSU, professional services and academic departments to promote and implement sustainability initiatives. We have created a dedicated sustainability email account to encourage ideas and feedback.

4. Our strategic aims

We have set out in the appendices of this report our aims to enhance our student and staff engagement (appendix A) and to develop sustainability in education (appendix B).

5. Implementation and engagement

Our sustainability working Group oversees direction on carbon reduction but ultimately many of our targets are down to individuals and their actions. We will plan awareness campaigns and increase our engagement with student and staff groups.

6. Responsibility, ownership and monitoring

Ownership of this plan ultimately rests with the Chief Operating Officer however actions will be monitored through the Sustainability Working Group.
