If you are a UK taxpayer, this Gift Aid declaration enables St Mary's University to reclaim the basic rate of tax paid on your gift, increasing its value by almost one-third at no extra cost to you.	
Please Note: If you are a higher rate tax payer, you can claim a rebate of the difference between the higher and the basic rate of tax through your Self-Assessment tax return. In order to gift aid your donations, you must have paid or will pay an amount of Income Tax and/or Capital Gains Tax for each tax year (6 April to 5 April) that is at least equal to the amount of tax that all the charities or Community Amateur Sports Clubs (CASCs) that you donate to will reclaim on your gifts for that tax year. VAT and Council Tax do not qualify. We will reclaim 28p of tax on every £1 that you gave up to 5 April 2008 and will reclaim 25p of tax on every £1 that you gave on or after 6 April 2008. If in the future you no longer pay tax on your income and capital gains equal to the tax that the University reclaims, you can cancel your declaration by contacting the Alumni Relations and Development Office.
