Our research is focused in the specific Research Centres which reflect the expertise and range of interest of our staff: The Benedict XVI Centre for Religion and Society, The Centre for Bioethics and Emerging Technologies (CBET), The Centre for Initiatives in Spirituality and Reconciliation (InSpiRe) and The Centre for the Social Scientific Study of the Bible (CSSSB), details of which can be found below.

As well as our distinguished academics we host regular research seminars, colloquia and conferences for research students at which they will meet the leading practitioners in their field. We also encourage students to present their own research at these meetings.
