# THE EDUCATION OF ORPHAN CHILDREN [SDG 1, 4, 5]

**PROJECT STATUS: CURRENT** 

**Project brief:** Occasionally SHOCC is asked to support the education of an individual child whose parents have died. It cannot support many such children and usually has to find donors who are willing to provide funding for the period of the child's education. At any one time, it is common to have 3-4 such children being supported, usually by anonymous donors.

**Background:** Many millions of children in the Global South have been left without parents as a result of civil wars and other difficulties. Often, these children are being looked after by grand-parents who are unable to provide fees for education. When approached by an existing school construction project, SHOCC will attempt to find the funds required to educated such young persons.

SHOCC will provide fees for pupils over the period of their education.

It will support the pupils through communication where appropriate.

Funds will also be provided for school uniforms and food.

A small amount of funding will also be provided for the person looking after the child, often a grandmother.

Funds will be transferred to a guardian or known local person such as the project manager of an existing SHOCC project. They will then be paid directly to the school involved.

The school will provide an education and will send regular reports on the child's progress.

The child will follow the normal school curriculum and will take examinations at the given times.

# **OUTCOMES**

What short-term changes (1-2 years) will result from the activities?

The child will progress at an appropriate rate.

The child mental health will improve.

The grandmother or other guardian will be relieved of the problems associated with feeding, clothing and providing an education for the child.

# **IMPACTS**

What longer-term significant changes (3-5 years) will the beneficiaries experience?

The child will progress through the education system and will move on to lead a useful life.

Several pupils at St Jude's Academy, Mto Wa Mbu and other schools in Tanzania and Kenya are being supported through their education by UK sponsors.

The sponsors have agreed to continue supporting the children until they complete their seven years of primary education. Some are supported through secondary schooling as well.

This requires a long-term commitment on the part of the sponsor. Funding is provided to an adult who supervises the pupil and liaises with the school, paying fees and sending regular reports and examination results detailing progress.
