# St Mary's CareerConnect Terms and Conditions

#### 1. Overview of CareerConnect

a. CareerConnect is a student experience software solution developed with university careers services to manage contact with students, graduates and employers more efficiently. 'Employability' is an increasingly important priority for universities. CareerConnect is key in preparing students for the world of work, engaging with employers, measuring progress and, most importantly, reaching more students.

# 2. Who can use CareerConnect

- a. CareerConnect is open for use by these groups:
  - i. St Mary's University Students
  - ii. St Mary's University Graduates
  - iii. Pre-entry students to St Mary's University
  - iv. St Mary's University Staff
  - v. Organisations who intend to advertise vacancies to the other registration groups. # 3. What CareerConnect can be used for

- a. St Mary's University Students, St Mary's University Graduates, Preentry students to St Mary's University, St Mary's University Staff ('Clients') registering can use CareerConnect for:
  - i. Booking appointments with Career Consultants
  - ii. Booking onto events

#### 4. Use of CareerConnect

- a. While accessing, browsing and/or using the Vacancies Site or the Services you must:

  - ii. not impersonate another person or use a false name or email address;
  - iii. act in good faith with, not misuse and treat in confidence any information provided to you.
  - iv. not make any misrepresentations in your use of the services
  - v. not affect, restrict, limit, inhibit anyone from using the services or the website;
  - vi. not post, transmit, submit, refer to, make available or link to or from (or authorise or permit any other person to do the same), or provide to St Mary's Careers Service, any material which in our opinion:
    - 1. is untrue, fraudulent, inaccurate or incomplete; and/or

- is obscene, threatening, menacing, offensive, defamatory, abusive, likely to cause annoyance, inconvenience or needless anxiety, is in breach of confidence, in breach of any intellectual property right (including, without limitation, copyright, designs or trade or service marks (whether registered or unregistered)) or otherwise is in breach of or violates any applicable law or regulation or code, and/or
- 3. directly or indirectly discriminates on grounds of age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex or sexual orientation; and/or
- 4. makes excessive demands for bandwidth

# 8. Termination, suspension and removal of access

  - i. terminate, suspend or deny your access to CareerConnect (whether in whole or in part); and/or
  - ii. cancel, terminate, suspend or deny your access to your Account; and/or
  - iii. remove or edit any information (including any material that you submit) on CareerConnect at any time. In such circumstances all liability of St Mary's University Careers Service, its directors, employees or other representatives for any loss whatsoever arising from our removing or editing information and/or your limited use of or inability to use CareersConnect site (either in whole or in part), your account and/or your logon or password is excluded, insofar as it is possible to do so in law.

Notwithstanding the first part of this section 10.a, St Mary's Careers Service excludes insofar as it is possible to do so in law all liability to you concerning such communications and your dealings with third parties.
- b. All information and/or data on CareerConnect is provided on an "as is" basis. Save to the extent required by law, no representations, warranties or terms of any kind are made (or shall be implied by statute or otherwise) in respect of CareerConnect or the content, including, without limitation, warranties of satisfactory quality, conformity to contract, accuracy, adequacy, conformity to description or fitness for any particular purpose. Your use of such content is entirely at your own risk.
- c. If the whole or any part of any provision of these Terms is or becomes invalid, void or unenforceable for any reason the same shall to the extent required be severed from these Terms and rendered ineffective so far as is possible without modifying the remaining provisions of these Terms and shall in no way affect the validity or enforceability of any other provisions.
- c. No waiver by St Mary's Careers Service and The Careers Group, University of London of any breach of these Terms shall constitute a waiver of any other prior or subsequent breach and St Mary's Careers Service and The Careers Group, University of London shall not be affected by any delay, failure or omission to enforce or express forbearance granted in respect of any of your obligations.
- d. The rights and remedies of St Mary's Careers Service and The Careers Group, University of London under these Terms are independent, cumulative and without prejudice to its rights under the law.
- e. These Terms are not intended to create and shall not create any rights, entitlements, claims or benefits enforceable by any third party by virtue of the Contracts (Rights of Third Parties) Act 1999.
- f. These Terms and/or your use of the Vacancies Site and/or the Services shall be governed by and construed in accordance with English law and the English Courts shall have exclusive jurisdiction over any dispute which may arise.
